held on 12th September 2020

Minutes

1. Apologies for Absence

The Chairman welcomed and thanked those present for attending.

Apologies were received from Philippa Gorm, John Glanville, Robin Chandler and Tracy Ansell.

2. Approval of 2019 AGM Minutes

The draft 2019 Annual General Meeting minutes were approved on a show of hands.

There were no matters arising.

3. Chairman's Report

This year has been an interesting time for all of us. There were so many things that I planned to do but didn't get the chance to do them unfortunately, but that's the way it goes sometimes. The big thing about this year has been the fact that so many people have found that there are other people in their neighbourhood that they like, and I think if there is one thing COVID-19 has done for us, it's proved to everybody that actually we can talk to our neighbours, and they're actually quite nice people, and that's made a big difference in our communities. We now have a situation where we are beginning to see genuine community cooperation from everyone which is wonderful.

What we need to do is to look carefully and thoroughly at the way Neighbourhood Watch has functioned over the last year and look at some of the lessons we have learned. One of the biggest lessons that I've learned from this is that we have a lot of members who are very dedicated, but they don't know what to do, and this has led to a number of areas just wallowing around wondering where their sense of direction is. I think one of the worst things you can have is an organization without a clear sense of purpose and in many areas, that is what we have.

What I would like us to do in the coming year is to address that. The original plan for last year was to have a big training event in March, but that was cancelled by the police having to deal with urgent duties and, obviously, Covid-19. Now that we have the Magic of Zoom, we can probably do a lot more than we've ever done before, and as most of us understand the technology now, and have got a decent enough internet connection to connect, what I am proposing we will do over the next year is to look at some of the things that we found are not working well from this year and start improving them and putting them right.

We have a very good structure now. We have worked very hard in the executive together we have now got very clear delineation of all our districts which is shown on the local group section of the national Our Watch site. That means we have a much better and clearer structure. We have got district MSA's who can look after the districts, we have got more policies than we ever had before, and we have a good strong constitution.

Now we've got to turn that into practice and what we've got coming up is the essential ingredient for us, this is to look at the two main things that we're responsible for, preventing crimes in our communities and looking at the wellbeing of communities. It would appear that we are just about on the cusp of going into the next wave of Covid-19. What we will have in our communities are large number of people who thought the worst was over and they are now going to find out that perhaps it wasn't. We are in the most appropriate position to identify people who might be sinking, going downhill physically and mentally and we are also in the best position to encourage people and give the right help and support to them. A lot of communities will need that. We are already seeing the crime coming up, and that will be an aspect of desperation and no doubt the fact that there are more people out and about and unusual and unexpected events are not as noticeable. We've have coming up quite a challenging time.

The good news is there is much better support from Neighbourhood Watch HQ. We have more materials to draw on than we've ever had. We also have the strengths that we each bring into the organisation. I'm hoping next year that we can run a series of Zoom training meetings for people to share information and support the coordinators who've been, in some areas, forgotten about. I think that's lamentable, and we need to put that right. We also need to make sure that we communicate with the members better and Zoom could give us the opportunity to do that. We now have a Zoom account for the Neighbourhood Watch Association, and I know Peterborough already have their own. We need to use Zoom and use other technology to embrace everybody, not just the odd people who can turn up to meetings like this one. Hopefully looking ahead there are a lot of positives. I would very much like people to look at things like Street Wisdom, which is totally free which is a way of using an urban environment to use mindfulness and improve wellbeing. It is very straightforward it is something I will share with the executive at the earliest opportunity because I think it has some strength in helping to reduce community stress.

One thing I will mention is that for many years now, Vic Kerlin has been a police contact for us. Vic has carried out a great deal of work behind the scenes to help Neighbourhood Watch. As with so many people who work behind the scenes, perhaps it is not fully appreciated how much has contributed to our work. He is moving on to other duties now. I want to publicly say thank you to Vic for everything he has done. There is also our other Vic who's changing his role a little bit on the executive, he is continuing to be the Webmaster still, so thanks for that Vic, it's an invidious job controlling computers, but it makes sense for Vic to continue to use his skills in that role as a co-opted member of the Executive. It is only fair that if I mention one Vic I should also mention the other.

We now have a new police contact, Inspector Ricky Passam who officially started work on 7th September and has been kind enough to attend our meeting today. Looking forwards, we have a lot to do. We have a strong executive that I am very pleased to be working with. We have some new things to learn about but remember that in every situation the most powerful things you can have are knowledge and a sense of purpose.

If you have knowledge and purpose everyone has the strength within them to tackle the challenges, we face. It is our task to make sure our communities have got the knowledge and support they need for both promoting improved wellbeing and for helping to prevent crime.

4. Treasurer's Report

A short written report was circulated in advance of the meeting.

The year commenced with a healthy cash bank balance and a large stock of signs. We also held deposit funds for St. Ives and Trumpington and this year added £383.33 to the deposit from March and District, which now total £751.91.

Sales of signs has been slower this year, not surprising since the advent of COVID and lockdowns. Trustee expenses have reduced as meetings have curtailed. Donations' principally from 'Patlock', have also reduced. There has been one grant to East Cambs. Association. In total there has been 13 transactions only.

In summary, we carry forward a net cash balance of just under £5000 and sign stock totalling 46 and valued at £524.78 in sales income.

7. Matters raised by Members

- John Fuller – Raised issue of the Police not getting information from communities to enable them to priorities areas. Highlighted Willingham as an example where concerns and incidents had been growing for some time but got out of control as the Police were not aware of them. We must take on board that we need to feed information back, even if we sometimes feel that we are not getting information from the Police. Please utilise the tools available – 101, online reporting and chat to report all incidents.
- Graham Carver – Raised issue of lack of response to Neighbourhood Watch events when he held them pre-pandemic. Need villages to take an interest.
- Alan Wilcher – Highlighted drugs bust in his area and impressiveness of the operation.
- Ricky Passam – Stated that areas know their long-term issues and need to communicate these to the Police. He recognised that information gathering takes time and response may not be immediate.
- Alan Paul, Kirsty Carter, Susanna C, Carol Leonard – all advocated the use of online reporting and chat facilities for reporting crime. Use of Social Media needs development and Robin reported that HQ are looking at ways of validating Facebook groups/pages as members.
